- 2.本章资料统计范围,根据建筑业发展的实际情况,从2002年年报起由原具有建筑业资质等级四级及四级以上的独立核算的建筑业企业调整为具有建筑业资质的独立核算建筑业企业。
- 3.本章建筑业企业统计数据是根据国家统计局制定的《建筑业统计报表制度》整理汇总的。资质内建筑业统计报表由国家统计局根据企业实际情况采取全面调查的方法布置、收集,2011年年报开始由资质内建筑业企业通过联网直报系统上报。

I Brief Introduction

- 1 .Main Contents:Data in this chapter show the general situation and the development of the construction industry in Xi'an. They cover the situation of production and operation of the construction enterprises, including the number of enterprises; total contract value; newly signed contract value; gross output value of the construction industry; the average number of employed persons engaging in the activities of construction enterprises; floor space of building completed in construction enterprises; profits of construction enterprises; value-added tax payable; labor productivity, etc.
- 2.Scope of Statistics:In view of the development of the construction industry, starting from 2002, the scope of construction statistics has been adjusted to include all the construction enterprises of various types of ownership with qualification certificates and independent accounting systems, replacing the previous criteria that required construction enterprises of various types of ownership to have qualification certificates at or above Class 4 with independent accounting systems.
- 3. Sources of Data and Methods of Survey: Data on construction enterprises are collected in accordance with the Statistical Reporting System of Construction by the National Bureau of Statistics. The construction statistical reports are deployed and collected through comprehensive surveys by the National Bureau of Statistics in accordance with the real conditions of the enterprises. Since 2011, construction enterprises with qualification certificates reported through internet.
- 4. The annual report 2019 cancels the production and operation table of labor subcontracting construction enterprises.
